### License Overview:

The TMMi Assessment Method (TAM) is licensed on the number of assessment (formal and in formal) to be conducted during the term of the license (1 year).

### Fees

Number of Assessments per annum	Yearly fee
Single assessment only	€ 795.00
1-3 assessments per year	€ 1,590.00
4-10 assessments per year	€ 3,180.00
Unlimited assessments per year	€ 10,600.00

*The TAM licence fee excludes pre-requisite software (IBM Notes runtime).*

### Multiple year discount fee

If a 3 years TAM license is purchased, a discount of 20% is offered on the yearly fee.
