License Overview:

The TMMi Assessment Method (TAM) is licensed on the number of assessment (formal and in formal) to be conducted during the term of the license (1 year).

TAM can only be used by those people who have successfully received Assessor Training (see web site for details), and It is not necessary to be an Accredited Assessor (unless conducting formal assessment)

We will then contact you with the necessary details of the registration procedure and obligations for becoming a recognized TMMi Professional training provider. There is no requirement to provide any training materials for review and accreditation, your effectiveness as a training provider will be measured by your trainees success in the exam.

- Continue to evolve the TMMi model to ensure it always remains relevant and available in multiple formats
- Respond to demand for TMMi materials and support in the Far East, particularly in markets such as China, Japan, and S. Korea
- Update and redesigned web-site, to improve attractiveness and improve sharing of information related to TMMi
